Explanation of Responses:

1. Each deferred Performance Restricted Stock Unit ("PRSU") represents a contingent right to receive one share of Common Stock.

2. The deferred PRSUs set forth in this row resulted from the vesting of a PRSU award granted by the Company on January 3, 2013. The ultimate number of PRSUs that could have been earned and vested under this award depended on (1) the total shareholder return for the Company relative to the companies in the Russell 2000 Index as of December 31, 2012 for the performance period beginning on January 1, 2013 and ended December 31, 2015 ("Relative TSR") and (2) whether the Company's absolute total shareholder return for the same period was positive or negative (collectively, the "TSR Measurement"). The Compensation Committee performed the TSR Measurement for this award on January 5, 2015. Based on the TSR Measurement, the maximum amount of PRSUs for the award, 80,477, were deemed earned and vested. In 2013, the reporting person elected to defer receipt of the Common Stock underlying the deferred PRSUs set forth in this row until January 30, 2017.

3. Deferred PRSUs do not have an expiration date.
