- 6. The reporting person transferred 20,000 shares of AMN Common Stock as a gift to charity.

- 13. The RSUs reflected in this row were granted on December 17, 2018 and vest on the first, second and third anniversary of the grant date and the grantees provision of three periods of credited service.
