- A Stock-Settled Appreciation Right ("SSAR") entitles the Grantee to the right to receive shares of AMN's Common Stock ("Stock") having a value equal to the excess of the Fair Market Value of the closing price of the Stock on the trading day prior to the date of exercise over the Exercise Price multiplied by the number of SSARs exercised. The number set forth in this row represents the difference between the number of SSARs exercised (8,224) and the number of shares of Stock issued as a result of the exercise (7,213).
- The SSARs set forth in this row were granted on April 9, 2009 pursuant to the AMN Healthcare Equity Plan and vested on the one year anniversary of the grant date.
